Employees' State Insurance Corporation, Maharashtra Region, has issued Offer of Appointment to the candidates selected for the post of UDC on 09.01.2024/13.02.2024 with the direction to submit the acceptance of Offer in writing in prescribed proforma on or before 31.01.2024/15.03.2024, respectively, and report for joining formalities on or before 31.01.2024/15.03.2024, respectively.

(2) DOPT instructions issued vide O.M. No. 35015/2/93-Estt.(D) dated 09.08.1995 and O.M. No. 1259494-Estt. (D) dated 09.08.2017 interalia stipulates that 'the offer of appointment would lapse if the candidate did not join within the specified period and would lapse automatically after the expiry of six months from the date of issue of the original Offer of Appointment'.

(3) 67 candidates have communicated non-acceptance of Offer and/ or failed to report for joining formalities despite given reminders/ extension and sufficient opportunities have been afforded to them.
